- 1. The dismantling and removal of partitions (Aluminum, POP, Wood) Fans, light fittings, Window A/Cs and, furnitures and scrap items *(No electrical wire should be removed)* from 3rd, LIC Building, No:1/1, Sampige Road, Malleswaram, Bengaluru.
- 2. The Care Taker, Office of the Principal Chief Commissioner of Income Tax, Ground Floor, C.R.Building, Queen's Road, Bengaluru, will arrange for Inspection of 3rd, LIC Building, No:1/1, Sampige Road, Malleswaram, Bengaluru.
- 3. Successful vendor shall submit Security deposit of `80,000/- by way of DD to the Cashier, Office of the Principal Chief Commissioner of Income Tax-I, II Floor, C.R.Building(Main), Queen's Road, Bengaluru.
- 4. The Security Deposit is to be forfeited in the event of the failure of the vendor to execute the work within **29-01-2016**.
- 5. The EMD amount will be forfeited, if the successful bidder fails to execute the work. For other bidders, the Earnest Money instrument will be returned after the completion of bid evaluation. No interest will be payable on this deposit.
- 6. Labour, Transport and Equipment required for dismantling and removal of partitions (Aluminum, POP, Wood) Fans, light fittings, Window A/Cs and, furnitures and scrap items shall be arranged by the vendor at his cost. Safety of the labourer should be ensured by the vendor while carrying out work. The Department takes no responsibility in this regard.
