2. The model, colour and year of manufacture of such vehicle preferably should be as below.



3. Hiring shall be initially for a period of 08 months which is extendable for another one year at the discretion of the Department, subject to the satisfactory services by the contractor. The vehicle should have the commercial taxi permit from the concerned authority. Maximum kilometers to be run by such vehicle shall not exceed 2000 kilometers in a month. All details are described under the head 'General Terms and Conditions' in the tender document.
