The vehicles are parked in Income Tax Property at No: 4 & 5, (next to IOB), Infantry Road, Bengaluru.
2. The successful tenderer shall submit security deposit by way of DD along with the tender. The tender without security deposit will be rejected.
3. The tendered amount shall be higher than reserve price. If the tendered amount is less than reserve price, the tender will be rejected.
