CORRIGENDUM TO E-TENDER NOTICE

**TENDER FOR OUTSOURCING OF 07 CLERICAL SUPPORT STAFF /06 MULTI TASKING STAFF IN
THE CHARGE OF CIT (INTERNATIONAL TAXATION) , BANGALORE**

Tender for outsourcing of 07 Clerical Support Staff and 06 Multi-tasking Staff in the Charge of CIT (International Taxation), Bangalore was floated vide tender documents uploaded in the Income Tax Bengaluru Website on 15.12.2016 and also on E-Publishing website of Central Procurement Portal.

In partial modification of the tender documents, the following amendments are being made: -

1. **For para 10 (page no. 4) of Terms condition in Section – III of Bid Document.**

The service provider is responsible for payment of monthly salary including leave salary, bonus, gratuity etc. to the personnel as applicable to them under law. The Service Provider should ensure that salaries are paid on time every month. It is mandatory for the service provider to pay the prevailing wages prescribed by the Minimum Wages Act, of the Karnataka Government to the CSS/MTS. The CSS will be paid the wages of clerical/non-technical staff and the MTS will be paid the wages for semi-skilled worker.

SHALL BE READ AS

The service provider is responsible for payment of monthly salary including leave salary, bonus, gratuity etc. to the personnel as applicable to them under law. The Service Provider should ensure that salaries are paid on time every month. **It is mandatory for the service provider to pay the prevailing wages prescribed by the Minimum Wages Act, of the Ministry of Labour & Employment, Govt of India (recently notified vide Notification No. 1/43(3)/2016-LS-II dated 30/09/2016) considering MTS as Unskilled and CSS as Highly Skilled.** The rates mentioned in the letter (for Area 'A' for MTS-374 for one day and CSS for one day 495) **includes Employees EPF and ESI Contribution and to be accounted for 26 Working Days in a month.**

2. The last date of bid receipt is extended to 05.01.2017 by 01:30 PM and bids will be opened at 03:30 PM on the same day.
