

Notice for empanelment of Advocates.

The Pr. Chief Commissioner of Income-tax, Karnataka and Goa proposes to engage the services of three / four senior standing counsels and six junior standing counsels to represent the Department before the Hon'ble High Court of Karnataka at Bangalore, Dharwad and Kalburgi Benches.

2. The Advocates willing to be empanelled should send their application in the Prescribed Proforma-A1, given below. The terms of engagement are governed by the Instruction No.7/2016, dated 07/09/2016 of the Central Board of Direct Taxes (CBDT).

3. The Advocates, who are eligible to appear before the High Court having minimum experience of 5 years in handling direct tax matters before the High Court or ITAT as an Advocate, may apply to be empanelled as Senior standing counsel. The Advocates with minimum experience of 3 years may apply for empanelment as Junior standing Counsels. The requirement is as under:

(a). For Bangalore Bench – 3 seniors and 4 juniors out of which one senior will be in the extended panel as per Instruction No.7/2016.

(b). For Dharwad Bench – 1 senior and 1 junior counsel.

(c). For Kalburgi Bench – 1 junior counsel.

4. It is preferable if the applicants are stationed at Bangalore, Dharwad and Kalburgi for the respective Benches for the sake of mutual convenience.
