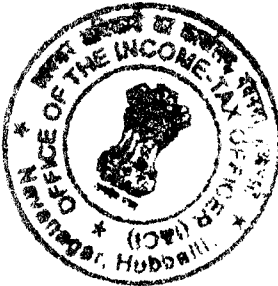



The hiring shall be initially for the period of one year from the date of commencement, and would be extendable for one more year at the discretion of the ITO(I&CI), Hubballi.
