TENDER NOTIFICATION FOR THE SUPPLY AND INSTALLATION OF STRONG ROOM FURNITURE AND FIXTURES

1. The **Office of the Principal Director of Income Tax(Investigation), Panaji, Goa**, invites sealed quotations for supply and installation of requisite furniture and fixtures for setting up of a Strong Room at Ground Floor, Aayakar Bhavan, EDC Complex, Patto Plaza, Panaji, Goa.
2. The tenderer is responsible for supply of all material and articles required for setting up a full fledged Strong room of size L. 3.0 mtr X W. 3.0 mtr X HT. 3.0 mtr with the supply and installation of 2 numbers 61SD Class C Defender Safes. The work should be commenced within 3 days and completed within 15 days of receipt of work order.
3. The tenderer should provide Bid Security of Rs. 40,000/- (Rupees Forty Thousand Only) by way of Bank Guarantee which will be valid for a period not less than forty five days from 10-03-2017.
4. The successful bidder is required to give a Bank Guarantee for Rs. 1,00,000/- (Rupees One Lakh Only) as Performance Security, which will be valid for a period of not less than 60 days of the completion of the contract.
5. Payment will be made by RTGS to the successful bidder on satisfactory completion of the contract and submission of the bill in favour of Pr. Director of Income Tax(Inv), Panaji. Normally the payment will take around 15 days from the date of submission of the bill.
6. Income Tax as applicable will be deducted at source from the payment.
7. Legal jurisdiction will be Panaji city only.
8. The details of each item of work with the price quoted should be submitted along with one copy of this tender duly signed in acceptance of the terms and conditions of the contract.
9. The Tender or quotations should reach this office by 10/03/2017 before 05.30 PM at the above address, either by speed post/registered post/hand delivery superscribing the name, address, contact person with telephone number on the envelope.
10. The sealed tenders/quotations will be opened on 14/03/2017 at 11.30 AM at the same address in the presence of the tenderer or his representative.
