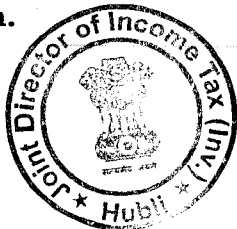


3. All bidders are required to strictly comply with the specifications as instructed in Section- III and Annexure - I & II (will be provided with the tender form).

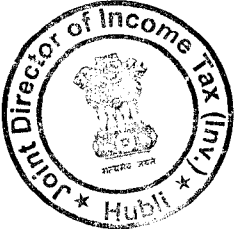

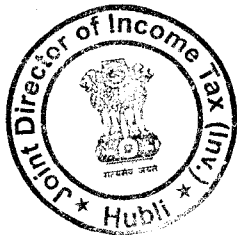
