
1. The Office of the Principal Director of Income Tax(Investigation), Panaji, Goa, invites sealed quotations from reputed distributors/suppliers for supply and installation of Server as specified below for the Income Tax, Investigation Unit, 4<sup>TH</sup> Floor, 'Laxmi Complex', Sadashiv Nagar, Belagavi, which will include all taxes and levies.

2. The work should commence within 3 days and completed within 20 days of receipt of work order.
3. The tenderer should provide refundable Bid Security of Rs. 20,000/- (Rupees Twenty Thousand Only) by way of Demand Draft in favour of "ZAO, CBDT, Panaji", which will be valid for a period not less than forty five days from 21-04-2017.
4. The successful bidder is required to give a Bank Guarantee for Rs. 40,000/- (Rupees Forty Thousand Only) as Performance Security, which will be valid for a period of not less than 60 days after the completion of the contract.
5. The bidder should have a valid PAN, Sales Tax/VAT Registration certificate.
6. Details of after-sale warranty/guarantee etc. are to be provided. Warranty period, as applicable, should be clearly specified as per the manufacturer's norms. Under no circumstances the warranty period offered by the bidder will be less than that offered by the manufacturers.
7. The Department shall take all necessary steps to make payment for the purchase and installation of the Server after submission of the bill, subject to the satisfaction of the Installation Committee. Payment will be made by RTGS to the successful bidder. Income Tax as applicable will be deducted at source from the payment.
8. The bidder shall sign and stamp each page of the tender and all other enclosures appended to it as a token of having read and understood the terms and conditions contained herein and submit the same along with the qualifying bid.
9. The Tender or quotations should reach this office by 20-04-2017 before 05.30 PM at the above address, either by speed post/registered post/hand delivery superscribing the name, address, contact person with telephone number on the envelope.
